TASK ORGANIZATION: MCB FORTY (Herein known as the Battalion)

1. SITUATION. Normal rotation of personnel within the Naval Construction Battalions requires a continuous training program to maintain the desired degree of readiness. Accordingly, it is necessary to move approximately 124 men of the Battalion from CBC Davisville to the MARCORPBASE CAMLEJ in March 1966 for military training under the following conditions:

a. Enemy forces. None.

b. Friendly forces. SERVLANT CBC DAVISVILLE
 FMFLANT MCB'S 6, 7 and 58
 MARCORPBASE CAMLEJ

c. Detachment. 124 Man Provisional Rifle/Weapons Company.

2. MISSION. Pursuant to reference (a), the Battalion is to deploy a Provisional Rifle/Weapons Company of approximately 124 men to CAMLEJ in conjunction with general military training and the use of crew-served weapons.

3. EXECUTION. When directed in March 1966 by the Commanding Officer MCB SIX, the Company will depart and deploy to CAMLEJ as an Attachment of MCB SIX for a period of approximately four weeks. While in transit and during training, the Company will maintain the same readiness condition as MCB FORTY.

4. ADMINISTRATION AND LOGISTICS:

a. Standard operational procedures, set forth by reference (b), will be followed.

b. Leave shall be administered in accordance with reference (c).

c. The Company will utilize Annexes A, B, C, X and Z of reference (d) while it is under MCB SIX OPCON.
