TASK ORGANIZATION: MCB SEVENTY-ONE (Herein known as the Battalion)

1. <u>SITUATION</u>. Reference (a) directed the establishment of the Battalion to be effective 1 October 1966, and designated CBC Davisville, Rhode Island as homeport. Upon commissioning, the Battalion will remain at CBC Davisville under the following conditions:

a. Enemy forces. None.

- 2. <u>MISSION</u>. Pursuant to reference (b), the Battalion will undergo an organizing, outfitting and training period to enhance the operational readiness of the Battalion so that it may fulfill its mission as a Mobile Construction Battalion.
- 3. EXECUTION. When commissioned in October 1966, the Battalion will remain at CBC Davisville for approximately six months. During this period, the Battalion will organize in accordance with reference (c) and maintain the readiness conditions required by its assigned contingency designation. During the homeport period, the Battalion will take maximum advantage of homeport facilities in order to improve its war readiness preparedness through improvement of its material condition and prosecution of a vigorous training program in accordance with the training assigned by Commander TWENTY-FIRST Naval Construction Regiment, including a conditioning deployment and preparation for an overseas deployment.

4. ADMINISTRATION AND LOGISTICS:

- a. Standard operational procedures set forth in reference (d) will be followed.
- b. Facility assignments will be made by the Commander TWENTY-FIRST Naval Construction Regiment.
 - c. Leave may be granted in accordance with reference (e).

- c. CBC Davisville Communication Center has communication guard and Fleet Post Office, New York has mail guard for the Battalion.
- d. File a movement report and report of commissioning in accordance with reference (g).
- e. The Battalion is authorized direct liaison with CBC Davisville and component activities.
