

DR. WILLIAM TURK PAPERS, 1744-1854

Introduction.

The Papers of Dr. William Turk, Fleet Surgeon, USN, were donated to the Naval Historical Center's Operational Archives Branch by Ms. Barbara H. Bell, Watkins Glen, New York. Ms. Bell, who had acquired the collection from a local family, held the papers for twenty-five years during which time she prepared a preliminary index and transcribed various documents in the collection. She also removed several documents relating to Dr. Turk's ancestors for inclusion in the archival collections of the New York City Historical Society. On 10 June 1995, she transferred the materials still in her possession to the Naval Historical Center.

Many of the papers were in small bundles and were unfolded and placed into acid free folders and boxes to insure their preservation and integrity. Because this initial examination of the papers indicated that the collection contained an abundance of historical information on nineteenth century Navy medicine which would be very useful to maritime scholars, the collection was processed immediately and made available to researchers.

The collection is quite comprehensive in chronicling Dr. William Turk's naval career from his appointment to his various ship and shore assignments as a surgeon. The medical reports submitted by Dr. Turk are a strong research asset because they document the "state of the health" of the U.S. Navy during the mid-1830s and provide details of the 1834 cholera outbreak on U.S. Ship DELAWARE. Dr. Turk's correspondence is also a research asset because the letters provide an insight into the life of a fleet surgeon and the difficulties he encountered with the Department of the Navy's bureaucracy.

The collection has no restrictions on its use and is open to all researchers. A computer finding aid for this collection is available for researcher use in the Operational Archives Branch. The Paradox for Windows format allows a researcher to view the entire checklist or conduct a search by subject.

Biographical Sketch of Dr. William Turk, Fleet Surgeon, USN.

- 1796 May 4 Received Baccalaureate from Columbia College.
- 1799 Jun 19 Received License to Practice Physic and Surgery in the state of New York.
- 1800 Jan 17 Appointed a surgeon's mate in the U.S. Navy. Served on U.S. Brig RICHMOND until 3 June 1801.
- 1801 Oct 30 Received Certificate to Practice in the Sate of New Jersey as a Physician and Surgeon.
- **1807 Apr 6** Appointed a surgeon of the First Regiment of Militia in the City and County of New York.
- **1812 Jul 16** Appointed a surgeon in the U.S. Navy and ordered to report to U.S. Frigate CONSTELLATION.
 - Jul 21 Accepted the appointment and orders to report to U.S. Frigate CONSTELLATION.
- 1813 Jul 24 Confirmation of appointment as surgeon by the Senate.
 - Aug 18 Ordered from U.S. Frigate CONSTELLATION at Norfolk to U.S. Frigate CONSTITUTION at Boston.
 - Oct 9 Ordered to U.S. Frigate PRESIDENT at Providence.

Scope and Content Note.

The papers relating to the naval service of Dr. William Turk date from 1744 to 1854 and comprise approximately 1 feet of materials. The collection consists of biographical data, his appointments and orders, correspondence, medical data, financial data, legal data, printed material, and miscellany. The bulk of the materials spans the years 1820 through 1854.

Some of the earliest documents relate to Dr. Turk's education, his certification and licensing as a physician and surgeon, and his religious affiliations. There is also biographical data on his father, Ahasuerus Turk, and his son, John William Turk, who changed his surname to Livingston in 1843.

Dr. Turk's appointment notices, his orders from the Department of the Navy, and the official correspondence document his naval service as a surgeon. His career with the U.S. Navy, beginning with the acceptance of his appointment on 21 July 1812 through the 1830s, provides an excellent insight into the administrative workings of the nineteenth century Navy. An excellent summation of Dr. Turk's naval service appears in his 6 June 1831 letter to the Secretary of the Navy.

The personal correspondence is also valuable because it places Dr. Turk's naval career in the context of life in the nineteenth century. In addition to his responsibilities as a U.S. Navy surgeon, he also had obligations as a son, husband and father. His relationship with his sons, John and James, and his financial responsibility for his daughter, Maria, who was confined to the Bloomingdale Asylum, add a personal dimension to his official naval career.

An extensive chronicle of Navy medicine for the 1832-1836 period is contained in Dr. Turk's medical reports to the Department of the Navy. The names and diseases of crew members on sick lists is available for U.S. Ship BRANDYWINE, U.S. Ship DELAWARE, U.S. Ship JOHN ADAMS, U.S. Frigate POTOMAC, and U.S. Schooner SHARK. These reports also provide information on the cholera outbreak in 1834-1835 and the "state of health" of the U.S. Squadron in the Mediterranean for the period 1 July-30 September 1836.

The financial documents contained in the collection supply information not only on Dr. Turk's official accounts with the Department of the Navy, U.S. Frigate CONSTELLATION, U.S. Frigate UNITED STATES, and U.S. Ship DELAWARE, but also on his personal finances. There is also a small number of legal documents which are personal in nature and include the last will and testament of Johannes Van Zeys, the great-grandfather of Dr. Turk.

The remainder of the collection is comprised of printed material and miscellany. Notable in these categories is a Bureau of Surgery and Medicine Booklet, "Instructions for the Government of the Medical Officers of the Navy of the U.S.," 1853, and an undated inventory for U.S. Ship UNITED STATES which includes medical provisions.

Series Description.

The Papers of Dr. William Turk are arranged by type of materials (series). The series titles include Biographical Data, Appointments, Orders, Correspondence, Medical Data, Financial Data, Legal Data, Printed Material, and Miscellaneous. Because six of the items are oversize, the original documents were removed from the standard size archival storage box and placed into an oversize archival storage box for preservation purposes. A folded photocopy of the document marks its original location in the arrangement sequence.

Series I, Biographical Data, 1765-1854, ca. 1/4 inch, chronological order. This series includes: biographies of Surgeon William Turk and his son, John William [Turk] Livingston; the Freeman Certificate of Dr. Turk's father, Ahasuerus Turk; Dr. Turk's Baccalaureate Degree and Medical Diploma; Dr. Turk's License and Certificate to practice as a physician and surgeon; his Russian passport; and miscellaneous documents relating to his religious affiliations.

Series II, Appointments, 1807-1813, ca. 1/4 inch, chronological order. This series includes: Dr. Turk's appointment as surgeon of the First Regiment of Militia in New York City and County; his appointment as surgeon in the U.S. Navy; and notice of the U.S. Senate confirmation of his commission.

Series III, Orders, 1810-1837 (1823-1837), ca. 1/4 inch, chronological order. This series includes an incomplete set of Dr. Turk's orders. This series does not include the documents relating to his leaves of absence. The documents granting those leaves are held in Series IV, Correspondence.

Series IV, Correspondence, undated and 1800-1853, ca. 5 inches, official correspondence arranged in chronological order/personal correspondence arranged by correspondent in chronological order. This series includes official correspondence with the Department of the Navy and personal correspondence with family members.

Series V, Medical Data, undated and 1832-1836, ca. 2 inches, arranged by name of ship or squadron in chronological order. This series includes sick lists with names and diseases (including number of cholera cases). Also includes a list of antidotes.

Series VI, Financial Data, 1806-1854, ca. 4 inches, official and personal accounts arranged in chronological order. This series includes: an account book (leather bound) which covers the period 1806-1839; accounts with various ships and the Department of the Navy; and personal bills and receipts.

Series VII, Legal Data, 1744-1853 (1834-1847), ca. 1/4 inch, chronological order. This series includes personal documents such as an indenture, a will, legal correspondence, and a fire insurance policy.

Series VIII, Printed Material, 1839 and 1853, ca. 1/4 inch, chronological order. This series is comprised of two items: an announcement of an art exhibition of Mr. Annelli's paintings and portraits and a Bureau of Surgery and Medicine booklet, "Instructions for the Government of The Medical Officers of the Navy of the U.S."

Series IX, Miscellaneous, undated, ca. 1/4 inch, chronological order. This series includes an inventory for U.S. Ship UNITED STATES and miscellaneous calling cards, notes, and envelopes.
