VAW-77 Command History

Command Composition and Organization Airborne Early Warning Squadron SEVEN SEVEN's (VAW-77) primary mission is to serve as a counter-drug command and control asset in our nation's war on drugs. VAW-77 is a Naval Reserve Squadron based at NAS Atlanta, Georgia, flying four Northrop Grumman E-2C Hawkeye aircraft. The command falls under the administrative control of Carrier Air Wing Reserve TWO ZERO while based at NAS Atlanta, GA, and under the operational control of Commander, Task Force FOUR ZERO while deployed. The squadron's operational commitment was 120 days per year until recently, when it was increased to a 150 day annual requirement. The area of operations while deployed has been the Caribbean. Tasking comes from Director, Joint Interagency Task Force EAST via the Tactical Support Center at Naval Station Roosevelt Roads. Squadron manning is composed of eighteen full time Training and Administration of the Reserves (TAR) officers, nineteen enlisted, twenty-six Selected Reserve Officers and ten enlisted. Maintenance on the aircraft is provided by thirty-nine Northrop Grumman contractor personnel.

- (2) 10 February 99 to 10 April 99 Counter-Drug deployment to NS Roosevelt Roads.
- (3) 11-14 May 99 Operation Bahamas Turks to Ft. Lauderdale, Florida.
- (4) 15 June 99 to 17 July 99 Counter-Drug deployment to NS Roosevelt Roads.
- (5) 10-14 August 99 Operation Bahamas Turks Detachment to Patrick AFB, FL.
- (6) 2 August 99 CDR B. P. Cutchen reports aboard as the new Executive Officer. CDR G. L. Bouts assumed the role of PXO until the change of command in January 2000.
- (7) 17 September 99 22 September Flew in Support of hurricane Floyd rescue efforts.
- (8) 19 October 99 to 21 December 99 Counter-Drug deployment to NS Roosevelt Roads.

3. Narrative

On 31 July 99 CDR B. P. Cutchen assumed the duties of Executive Officer. VAW 77 provided support to Operations Bahamas Turks with

3 Detachments and flying 31 sorties for a total of 87 hours. The squadron was called into provide Command and Control in the state of North Carolina in support of Hurricane Floyd Rescue efforts. The Squadron flew 21 flights for a total of 62 hours supporting the rescue efforts for over 2000 state residents.

VAW 77 was awarded the Joint Meritorious Unit Award for calendar year 1997 and the Meritorious Unit Commendation for the period of 01 October 95 to 28 May 1998. The Squadron was also awarded the Battle "E" for calendar year 1998. To date VAW-77 has flown 6676.5 hours and 1755 sorties in support of Counter-Drug operations. The squadron has been directly responsible for the seizure of 20.4 metric tons of cocaine and 10.5 metric tons of marijuana enroute to the United States.
