2. Commander's Assessment

As the "Oldest and Boldest" squadron in the United States Navy, the Officers and Sailors of Strike Fighter Squadron FOURTEEN are honored to continue the tradition of excellence that began nearly a century ago. The TOPHATTERS excelled during a 12-month period of increased operational tempo in 2016. Their continued superior performance operating at sea led to the squadron receiving both the CVW-9 "Golden Wrench" and "Top Hook" awards for the WESTPAC deployment, and the pace did not slow after returning home. Fighting FOURTEEN leaned on the stead-fast work ethic of their award winning maintainers to accomplish an aircraft transition despite just arriving home from deployment. The TOPHATTERS continue to prove themselves as leaders within the Strike Fighter Community and more importantly within Naval Aviation as a whole.

3. Chronology

Narrative

On January 20th, 2016, after completion of a normal workup cycle, VFA-14 embarked on USS John C. Stennis (CVN-74) as a part of Carrier Strike Group THREE (CSG-3) and Carrier Air Wing NINE (CVW-9) for a scheduled WESTPAC deployment. After CVW-9 finished carrier qualifications in the Southern California working areas, the ship turned west to begin the 2016 WESTPAC deployment.

As CSG-3 pressed west, the air wing had a chance to execute normal CVN flight operations in the vicinity of Hawaii while the surface ships participated in USWEX in early February. VFA-14 dropped light inert practice bombs on the small island range nicknamed "K-rock", and live ordnance on the PTA bombing range located on the big island of Hawaii in order to maintain strike proficiency.

The next opportunity for training came when the ship arrived off the coast of Guam in early February. VFA-14 once again had the opportunity to brush up their strike skills dropping light inert ordnance on the small island bombing range north of Guam called FDM.

After a brief port call in Guam, CSG-3 headed northwest towards the first island chain. From March 11th to 26th VFA-14 conducted operations in support of Foal Eagle, an annual joint exercise between the Republic of Korea (ROK) and the United States. In the cold waters of the Sea of Japan, CVW-9 flew joint missions with the ROK for two weeks. CSG-3 made another port call in Busan, South Korea for a few days, and then steamed south toward the South China Sea.

CVW-9 maintained routine Defensive Counter Air (DCA) patrols, Surface Search and Combat (SSC) patrols, as well as regular Unit Level Training (ULT) during their time in the South China Sea. CSG-3 garnered both national and international attention while operating in the Pacific Area of Responsibility (AOR). Partner and ally nations in the region welcomed our cooperation and support, and the CSG-3 team was visited by numerous foreign and domestic dignitaries; including the Chief of Naval Operations, Secretary of Defense from both the United States and the Philippines, and the Vice President of the United States.

On May 19th, while still in the South China Sea, VFA-14 held an airborne change of command to welcome their new Commanding Officer CDR Brian "Stickit" Emme. CDR Emme replaced CDR Corey Pritchard as the 86th Commanding Officer of VFA-14.

USS John C. Stennis started the long journey home in early June. After a brief delay near the ODJ bombing range near Okinawa, CSG-3 entered port in Pearl Harbor to participate in the biennial Rim of the Pacific Exercise (RIMPAC). During RIMPAC, Fighting FOURTEEN worked with both aircraft and surface ships from the navies of 26 different nations, further improving the multinational and joint capabilities of modern naval forces to respond and cooperate through a multitude of modern day Pacific challenges.

After the conclusion of RIMPAC, John C. Stennis turned east toward home. Fighting FOURTEEN welcomed their pilots back to Lemoore after being away from family and friends for seven months at a fly-in event on August 8th.

Over the course of the deployment VFA-14 flew 1779 sorties for 2930.2 hours, and qualified one strike lead, four division leads, and one section lead. The continued superior performance by the "TOPHATTERS" led to the squadron receiving both the CVW-9 "Golden Wrench" and "Top Hook" awards for deployment.

Waiting for the "TOPHATTERS" when they arrived home was a jet transition to high-lot Super Hornets as part of the Naval Aviation Enterprise's efforts to manage service life across the fleet. During the transition, the squadron leaned on the stead-fast work ethic of their award winning maintainers to get the job done despite just arriving home from deployment.

As the year came to a close, VFA-14 provided REDAIR support for CVW-2 during their COMPTUEX. Fighting FOURTEEN operated out of NAS North Island from November 14th-22nd.

In total, VFA-14 flew approximately 2700 sorties for 4200 hours in the calendar year of 2016.
