10 March 1947:

Upon completion of Fleet Maneuvers, Attack Squadron One Able flew ashore to become temporarily shore based at NAS, Ford Island, Oahu, T.H.

28 March 1947:

Attack Squadron One Able temporarily shore based at NAS, Ford Island, Oahu, T.H.

ATTACK SQUADRON ONE ABLE, a component of Attack Carrier Air Group One, Air Force, Pacific Fleet was temporarily shore based at NAB, Kobler Field, Saipan, Marianas Islands, on 28 December 1946, and had been in commission since 12 May 1945. LCDR H. W. CALHOUN, USN was the squadron's Commanding Officer and LCDR G. E. MILLER, USN was the Executive Officer.

On 9 January 1947 ATTACK SQUADRON ONE ABLE flew aboard the USS TARAWA bound for

Pearl Harbor with Guam as an intermediate stop.

The USS TARAWA anchored in Apra Harbor, Guam, Marianas Islands on 10 January 1947 for a five day stop. On 15 January 1947, departure was taken for Pearl Harbor. The ship had a Marine detachment aboard for transit purposes, so no air operations could be conducted. On 20 January 1947, the USS TARAWA crossed the International Date Line thereby gaining a day.

On 23 January 1947, ATTACK SQUADRON ONE ABLE was launched to become temporarily shore based at NAS, Barbers Point, Cahu, T.H. An intensive flying and training schedule was immediately set up which stressed rocket fire, glide and dive bombing,

navigation, and carrier qualification.

On 28 January 1947, Ens. R. M. LARSON, USNR of Waupaca, Wisconsin had a fatal accident. On recovery from a rocket run he reported propeller failure, stalled out on approach to landing, and hit the water in an inverted position. The plane sank immediately with no survivor.

On 10 February 1947, ATTACK SQUADRON ONE ABLE flew aboard the USS TARAWA for Fleet Maneuvers. Strikes were flown against the Hawaiian Islands and in the after-

noon of 13 February 1947 the USS TARAWA moored at Ford Island, Oahu, T.H.

On 17 February 1947, the USS TARAWA, with ATTACK SQUADRON ONE ARLE aboard, departed Ford Island for Kwajalein Atoll after rendezvousing with Task Force Fifty-Seven for Fleet Maneuvers. On 28 February 1947, Ens. W. H. TEEPLE, USNR of Sault Ste. Marie, Michigan had a fatal accident during landing operations. He tried to take a voluntary wave-off after taking a cut, hit the right catwalk, and fell into the water. He got out on the wing of the plane but went down with it.

The USS TARAWA crossed the International Date Line on 1 March 1947 thereby gaining one day. ASP's and strikes were flown against Task Force Fifty-One.

On 4 March the USS TARAWA rendezvoused with and became part of Task Force Fifty-One. Strikes were flown against Johnston Island on 6 March 1947 and against Cahu, T.H. on 10 March 1947.

ATTACK SQUADRON ONE ABLE became temporarily shore based at NAS, Ford Island, Oahu, T.H. on 10 March 1947 when it landed after the strikes on Oahu, T.H. A basic flying and training schedule was immediately set up which stressed instruments,

division and group tactics, and navigation.

On 28 March 1947, ATTACK SQUADRON ONE ABLE was temporarily shore based at NAS, Ford Island, Oahu, T.H. The squadron was composed of twenty-four pilots and ninety enlisted men. Twenty-one SB2C-5's and two SBW-5's were assigned to the squadron.

During the period from 28 December 1946 to 28 March 1947 two pilots were killed in the squadron, eight pilots were detached from the squadron, and no pilots joined the squadron. Seventeen enlisted men were transferred from the squadron and fourteen enlisted men joined the squadron.

ATTACK SQUADRON ONE ABLE, a component of Attack Carrier Air Group One, Air Force, Pacific Fleet was temporarily shore based at NAS, Ford Island, Oahu, T.H. on 28 March 1947 and had been in commission since 12May 1945. LCDR H. W. CALHOUN, USN was the squadron's Commanding Officer and LCDR G. E. MILLER, USN was the Executive Officer.

The period from 28 March 1947 to 16 April 1947 was spent in an intensive training program in type instruments and cross-country flying. Air support, field carrier landing practice, and two parade formations were also flown.

On 16 April 1947, ATTACK SQUADRON ONE ABLE flew aboard the USS TARAWA and in the afternoon the USS TARAWA moored at Ford Island, Oahu, T.H.

On 23 April 1947, the USS TARAWA, with ATTACK SQUADRON ONE ABLE aboard, departed Ford Island for NAS, Alameda, California with NAS, San Diego, California as an ultimate destination. No air operations were conducted since the USS TARAWA was loaded with aircraft being returned to the United States for overhaul. On 29 April 1947, the USS TARAWA arrived at NAS, Alameda, California.

After the aircraft for overhaul were placed ashore, the USS TARAWA departed for NAS, San Diego, California on 30 April 1947. On 1 May 1947, ATTACK SQUADRON ONE ABLE was launched to become shore based at NAS, San Diego, California.

The period from 1 May 1947 to 15 June 1947 was spent in leave and recreation. Flying was held to a bare minimum and consisted only of area familiarization.

On 16 June 1947, an intensive training schedule was set up which stressed familiarization, division tactics, and type instruments in preparation for night flying.

On 28 June 1947, ATTACK SQUADRON ONE ABLE was temporarily shore based at NAS, San Diego, California. The squadron was composed of twenty-seven pilots and eighty-six enlisted men. Twenty-three SB2C-5's were assigned to the squadron.

During the period from 28 March 1947 to 28 June 1947 seven pilots were detached from the squadron and ten pilots joined the squadron. Fourteen enlisted men were transferred from the squadron and ten enlisted men joined the squadron.

ATTACK SQUADRON ONE ABLE, a component of Attack Carrier Air Group One, Air Force, Pacific Fleet was shore based at NAS, San Diege, Galifornia on 28 June 1847 and had been in commission since 12 May 1945, IGDR N. W. SALMOWN, USN was the squadron's Sommanding Officer and LSDR G. E. WILLER, ESN was the Executive Officer.

The period from 28 June 1947 to 5 July 1947 was spent in division tactics, type instruments, and angle calibration for rocket fire.

On 5 July 1947, ATTACK SQUADRON ONE ABIZ flow to MAS, El Contro, Salifornia. After completing a rocket and might flying syllabus, ATTACK SQUADRON ONE ABIZ returned to MAS, San Diego, Galifornia on 18 July 1947.

An intensive training schedule was resumed which stressed field carrier landing practice, all types of banking, and group tactics as well as refresher hops for rocket firing and night flying.

On 18 July 1947, LEDR H. W. CALMOWN, WEN was relieved as Commanding

Officer of ATTACK EQUADRON ONE ANIE by LEDR J. K. SLIFFORD, USN.

On 8 September 1947, ATTACK SQUADRON ONE ABLE flow aboard the WSS TARAMA for Carrier Qualification and Inter-Type Exercises. On 5 September 1947, Carrier Qualification was completed and the planes were flown to HAS San Diego, California. The USS TARAMA moored at HAS, San Diego, California in the afternoon.

On 8 September 1847, the planes of ATTAGE SQUADROW ONE ABLE flow aboard the USS TARAWA, refueled, and returned to HAS, San Diego, California. On 9 September 1947, the planes returned to the USS TARAWA for refresher and Inter-Type Exercises. On 11 September 1847, the USS TARAWA moored at NAS, San Diego, California for the weekend.

On 15 September 1947, the USS TARAMA with ATTAGE SQUADRON ONE ABLE aboard, departed MAS, San Diego, Galifornia for Inter-TypeExercises as a part of Task Force 51. Searches, anti-sub patrols, and simulated strikes were flown and upon completion of the exercises, the USS TARAMA moored at Engler's Point, San Francisco, Galifornia on 26 September 1947.

On 28 September 1947, ATTACK SQUADRON ONE ABLE was aboard the WSS TARAMA moored at Hunter's Point, San Francisco, California. The squadron was composed of twenty-eight pilots and one hundred thirty-five emlisted

men. Iwenty SBEG-5's were assigned to the squadron.

During the period from 28 June 1947 to 28 September 1947 four pilots were detached from the squadron and five pilots joined the squadron. Eight emlisted men were transferred from the squadron and fifty-seven enlisted men joined the squadron.

III APPENDICES

Biographical Sketch of Commanding Officer

Lieutement Commander John K. Slifford, USE, of Tacoma, Washington become Commanding Officer of Attack Squadren One Able on 18 July 1947, relieving Lieutement Commander Mareld W. Calhoun, USE. At that time he had six years of Maval experience, including three years with Bombing Squadren TERME and two years with MAS, San Diego, California.

Clifford enlisted in the Maval Reserve in Jamuary 1941 and was appointed Aviation Cadet in April 1941. He was assigned to flight training at Corpus Christi, Texas from which station he graduated in November 1941. From December 1941 to May 1942 Ensign Clifford was assigned to the advanced Carrier Training Group before reporting to Bombing Squadron THRES in June 1942.

He served with Bombing Squadron THREE from June 1942 to April 1945 during which time the squadron was attached to the USS SARATOGA and the new USS YORKTOWN. He participated in nine major engagements in the Pacific Area for which he was awarded the Havy Cross, Distinguished Flying Gross with one gold star, and Air Medal with three gold stars.

Lieutement Clifford reported to MAS, San Diego, California in May 1945 and was assigned to AAR as Chief Test Pilet. He was promoted to the rank of Lieutement Sommander in October 1945 and transferred to the Regular Huvy In July 1946. In August 1946 he became Assistant Executive Officer of the Maval Air Station.

In July 1947 Lieutenant Commander Clifford reported to Attack Squadron One Able as Commanding Officer relieving Lieutenant Commander Salhoun. VA-1A/A9-3/HEO

LCDR J. K. CLIFFORD, USN was the Squadron's Commanding Officer and LCDR G. E. MILLER, USN was the Executive Officer.

On 29 September 1947, the USS TARAWA with ATTACK SQUADRON ONE ABLE aboard, departed Hunter's Point, San Francisco, California for San Diego, California. On 30 September 1947 ATTACK SQUADRON ONE ABLE was launched to become shore based again at NAS, San Diego, California.

The period from 1 October 1947 to 8 October 1947 was spent in preparation to move the squadron to NAS, Seattle, Washington. No air operations were conducted.

On 8 October 1947, ATTACK SQUADRON ONE ABLE departed for NAS, Alameda, California and arrived there in the afternoon. Due to poor weather the squadron didn't depart for NAS, Seattle, Washington until 12 October 1947.

An intensive training schedule was established which stressed G.C.A., type instruments, and night flying. Due to poor weather conditions no gunnery and very little bombing was done.

On 21 November 1947, ATTACK SQUADRON ONE ABLE departed for NAS, Alameda, California and arrived there in the afternoon. On 22 November 1947, the squadron arrived at NAS, San Diego, California.

An intensive training schedule was established which stressed dive-bombing, gunnery, night flying, and dual instruments.

Om 28 December 1947, ATTACK SQUADRON ONE ABLE was shore based at NAS, San Diego, California. The squadron was composed of twenty-five pilots and one hundred - fourteen enlisted men. Twenty SB2C-5's and 1 SNJ-4 were assigned to the squadron.

During the period from 28 September 1947 to 28 December 1947 three pilots were detached from the squadron and no pilots joined the squadron. Thirty-nine enlisted men were transferred from the squadron and eighteen enlisted men joined the squadron.

- 28 December 1947: Attack Squadron One Able shore based at NAS, San Diego, California. Commanding Officer; Lieutenant Commander John Kingdon Clifford, USN, of Tacoma, Washington.
- 29 January 1948: Carrier qualification landings conducted aboard the U.S.S. Boxer (CV-21).
- 24 February 1948: Midshipman James Walter Skoog, USN, of Willmar,
 Minnesota was killed.
- 1 March 1948: Embarked aboard the U.S.S. Boxer (CV-21) to conduct Air Group carrier qualifications.
- 6 March 1948: Disembarked U.S.S. Boxer (CV-21) outside the Golden Gate, San Francisco, California, and returned to NAS, San Diego, California.
- 17 March 1948: Attack Squadron One Able received the first of the F4U-4 Corsairs with which it will replace the SB2C-5 Helldivers in the near future.

ATTACK SQUADRON ONE ABLE, a component of Attack Carrier Air Group One, Air Force, Pacific Fleet, was temporarily shore based at Naval Air Station, San Diego, California, on 28 December 1947, and had been in commission since 12 May 1945. Lieutenant Commander John Kingdon CLIFFORD, USN, of Tacoma, Washington was the Squadron's Commanding Officer and Lieutenant Commander Gerald Edward MILLER of Quincy, Illinois was the Executive Officer.

On 6 January 1948 Lieutenant Commander Gerald Edward MILLER of Quincy, Illinois was relieved of his duties as Executive Officer of ATTACK SQUADRON ONE ABLE by Lieutenant Commander James Woodrow WYRICK, USN, of Vallejo, California.

The period from 8 January 1948 through 7 February 1948 was spent in close air support training in prepartion for rendering close air support for the practice amphibious landing operations off the coast of southern California near the Aliso Canyon area.

On 29 February 1948 ATTACK SQUADRON ONE ABLE conducted re-qualification landings aboard the U.S.S. BOXER (CV-21) which was operating off the coast near San Diego, California. Sixteen pilots participated in the re-qualification and a total of fourty-eight landings were made.

On 10 February 1948 ATTACK SQUADRON ONE ABLE was scheduled to support the practice amphibious landing operations off the coast of southern California, but this operation was called off due to adverse weather conditions.

On 24 February 1948 Midshipman James Walter SKOOG, USN, of Willmar, Minnesota was killed while engaged in dive bombing practice on a land target southeast of Naval Air Station, San Diego, California. Midshipman SKOOG

pulled his plane out of a dive bombing run abruptly resulting in a high speed stall and spin from which he did not recover.

On 1 March 1948 ATTACK SQUADRON ONE ABLE embarked aboard the U.S.S.

BOXER (CV-21). During the period from 1 March through 6 March 1948 the squadron was engaged in carrier qualifications with the air group. Sixteen pilots participated in these qualifications, a total of one hundred and seventy-three landings and thirty-six catapult launchings were made.

On the morning of 6 March 1948 ATTACK SQUADRON ONE ABLE flew off the U.S.S. BOXER (CV-21), which at that time was cruising off the coast of California near the city of San Francisco, California. The Squadron departed for the Naval Air Station, San Diego, California, where it arrived that afternoon.

On 17 March 1948, in compliance with directives from higher authority, ATTACK SQUADRON ONE ABLE received it's first two F4U-4 Corsairs. This was the begining of the Squadron's transition period of changing from SB2C's to F4U's. The first F4U-4 flight in the Squadron was made by Lieutenant Junior Grade Arthur Warran JONES at 0950, 18 March 1948.

On 22 March 1948 ATTACK SQUADRON ONE ABLE commenced an intensive two weeks nite flying syllabus. During this period the squadron's working day was from 1500 until 2400.

on 31 March 1948 ATTACK SQUADRON ONE ABLE was temporarily shore based at Naval Air Station, San Diego California. The squadron was composed of twenty-three officers on flying status and ninety-four enlisted men. Ten SB2C-5 Helldivers, ten F4U-4 Corsairs, and one SNJ-4 Texan were assigned during this transition period from SB2C's to F4Ú's.

During the period from 28 December 1947 to 31 March 1948 nine officers

were detached from the squadron and eight officers reported for duty aboard the squadron. The Squadron experienced one fatality in the death of Midshipman SKOOG. Twenty-eight enlisted men were transferred from the squadron and eight enlisted men reported for duty aboard the squadron.
