COMMAND HISTORY USS GONZALEZ (DDG 66) 01 JANUARY 2002 TO 31 DECEMBER 2002

1. Command History and Organization

The mission of USS GONZALEZ (DDG 66) is to conduct prompt, sustained combat operations at sea in support of U.S. National Policy. GONZALEZ is equipped to operate in a high density, multithreat environment as an integral member of a Carrier Strike Group, Expeditionary Strike Group, Surface Action Group, or underway replenishment group. GONZALEZ' combat systems provide capabilities in Air Warfare (AW), Anti-Submarine Warfare (ASW), and Surface Warfare (SUW), projecting power throughout all spectrums of maritime operations.

USS GONZALEZ (DDG 66) is home-ported in Norfolk, Virginia and assigned to Destroyer Squadron Eighteen, with Unit Identification Code V21833. CDR Karl J. Van Deusen is the Commanding Officer. LCDR Bruce A. Apgar, Jr. is the Executive Officer.

3. Summary of Events for 2002.

At the start of 2002, GONZALEZ participated in Anti-Submarine Warfare exercises in the Narragansett Bay. This useful training marked the beginning of the Inter-Deployment Training Cycle (IDTC).

February through April 2002 was dedicated to intensive maintenance to materially prepare the ship for deployment in 2003. In February, hardware was installed to upgrade the combat system capability, including the Advanced Tomahawk Weapons Control System. During March, GONZALEZ entered a Restricted Availability maintenance period. During this availability, GONZALEZ Sailors completed a comprehensive industrial package without contractor support.

In May, preparations began in earnest for the upcoming Light-off Assessment (LOA) and Initial Assessment (IA). This preparation culminated in a successful LOA at the end of May. The month of June was focused more intensively on preparations for IA. GONZALEZ served as a training platform for Midshipmen from both the Naval Academy, and various Naval Reserve Officer Training Corps (NROTC) units during June. Midshipmen were introduced to life at sea as a Surface Warfare Officer. Also in June, GONZALEZ successfully certified the Advanced Tomahawk Weapons System and aviation facilities, and had a successful Navy Food Management Assist.

July began with a visit to Eastport, Maine. A long tradition exists of Navy Ships visiting Eastport for Independence Day celebrations dating to the 19th Century. July culminated in a successful Cruise Missile Tactical Qualification, and a successful IA.

August began with a two-day visit to the National Maritime Museum (Nauticus) in downtown Norfolk, Virginia. GONZALEZ conducted "Family Day Cruise" in August, allowing Crewmembers' families to get underway for a day and experience life as their loved ones experience it in service to their country. The crew continued preparations in August and September for the upcoming Board of Inspection and Survey (INSURV) visit. This inspection has been mandated by the United States Congress, and occurs aboard Naval Ships approximately every five years. GONZALEZ conducted a Tailored Ship's Training Availability (TSTA) while enroute Nassau, Bahamas. TSTA honed watchstanders' warfighting and damage control skills while transiting to this exotic port of call.

The first two weeks of October were spent preparing for and executing a successful INSURV inspection. After the assessment, GONZALEZ sailed to Mayport, FL conducting TSTA B. GONZALEZ was honored by a visit from RADM Stavridis, Commander of ENTERPRISE Battle Group.

November and December were consumed largely by inport inspections and intensive preparations for Underway Demonstration (U/W Demo) and the Final Evaluation Problem (FEP). In November, GONZALEZ completed a successful Supply Management Inspection (SMI) and a Maintenance-Material-Management (3M) Inspection. Then, following a brief break for the Thanksgiving Holiday, GONZALEZ completed U/W Demo and FEP. The FEP certifies a ship as ready to proceed to advanced training.

On December 13, 2002, CDR Karl J. Van Deusen relieved CDR Andrew A. King as Commanding Officer, and the crew transitioned to a Holiday Leave Period.
